Land Use Change: Land Owner Phyllis Toay; Applicant – Toay Farms LTD Partnership/Daniel Toay - Parcel #024-0783 (Change 2 (+/-) acres from 40 Ag to Ag Residential): Daniel Toay, Applicant/Phyllis Toay, Landowner - Land Use Change Application to rezone 2.39 (+/-) from Agriculture to AR-1 Ag Residential Section 11, T5N, R4E, PT NE ¼ of SW ¼ – Parcel # 024-0783 (2225 South Clay Hill Road). Land Use/Rezone/Conditional Use: Land Owner James W Johnson – Parcel 024-0536 & 0537 (Change 2-3 acres from Ag to RB-1 for a wedding barn): Land Use/Rezone/Conditional Use: To rezone 5 acres currently Agriculture to Recreational Business (RB-1) – proposed use as a wedding barn. Section 26, T6N, R4E, SW ¼, NW ¼ – Parcel # 024-0536 & 024-0537 (6620 Johnson Drive, Ridgeway). Conditional Uses:

Noise restriction to 90 decibels at the property line

Capacity of 250 People

Light will face downward, except illuminating the American Flag

Commercial code bathroom facilities shall apply with the relevant codes

Hours of operation 8 AM to 12 AM

Food/beverage shall be by catering businesses only, no commercial kitchen allowed.

Narveson made a motion to approve the application as presented with the Conditional Uses. Lease seconded. Motion carried. Johnson abstained.
