Thursday, December 31st from 10:00am to 2:00pm

Saturday, January 30th from 10:00am to 2:00pm

IMPORTANT TAX COLLECTION INFORMATION:

- You can mail your taxes any time to me at my home address
- If you need a receipt, send a self-addressed stamped envelope
- **NEW * NEW *** Due to system upgrades if you want to pay for 2016 garbage collection with your taxes, you will have to write a separate check. **DO NOT** include it on the same check as your taxes. This created quite a snafu last year with processing. You can include your dog license payment on your tax check, that still works. I recommend paying garbage this at this time, to avoid the late charge.
- **If a manual split is requested, one week notice is needed prior to due date.**

Clean Sweep Clean Sweep will be April 30th. There will be a charge for tires, and appliances (TV, A/C, fridge/freezer, etc.). We **will not** accept building /construction waste, paint cans with paint that is NOT dried up. And remember to separate out your oil filters, this is important, if found in dumpster there will be a hefty fine for the Township.

Dog Licenses Dogs need to be licensed by April 1st. Fees are: Spayed/Neutered \$6.00 and Male/Female \$12.00. A proof of vaccination from your vet is needed when licensing. If you are current and have licensed in the past year the form should be on file.

***NEW* Voter Requirements** If you are a registered voter you will need to show **one** of the following to receive a ballot: A WI-DOT driver's license, a WI-DOT issued identification card, Military ID card issued by the US Uniformed Services, or a US passport book or card.
